## **REGULATION**

**Art.1.- The "SALT DE TRAMUNTANA"** is a cyclosporive event whose route is from Selva to Coll de Sa Batalla and return, in a circuit totally closed to traffic of 21.4 km in which you can choose to participate over two distances:

- 42.8 km (2 laps of the circuit).
- 85.6 km (4 laps).

During the registration process you must choose the distance in which you wish to participate.

Each race finishes when the first runner of each distance completes the course, leaving the remaining runners to finish the lap they have started.

The organizers will place cones in the center of the road. Participants must use the right-hand lane. Overtaking in the other lane is not permitted under any circumstances.

Minimum age to participate is 15 years old in 2024 for the 42.8 km distance and 17 years old in 2024 for the 85.6 km distance.

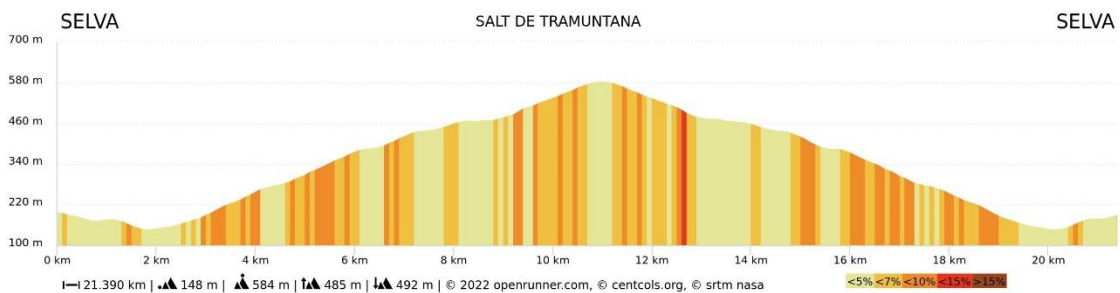
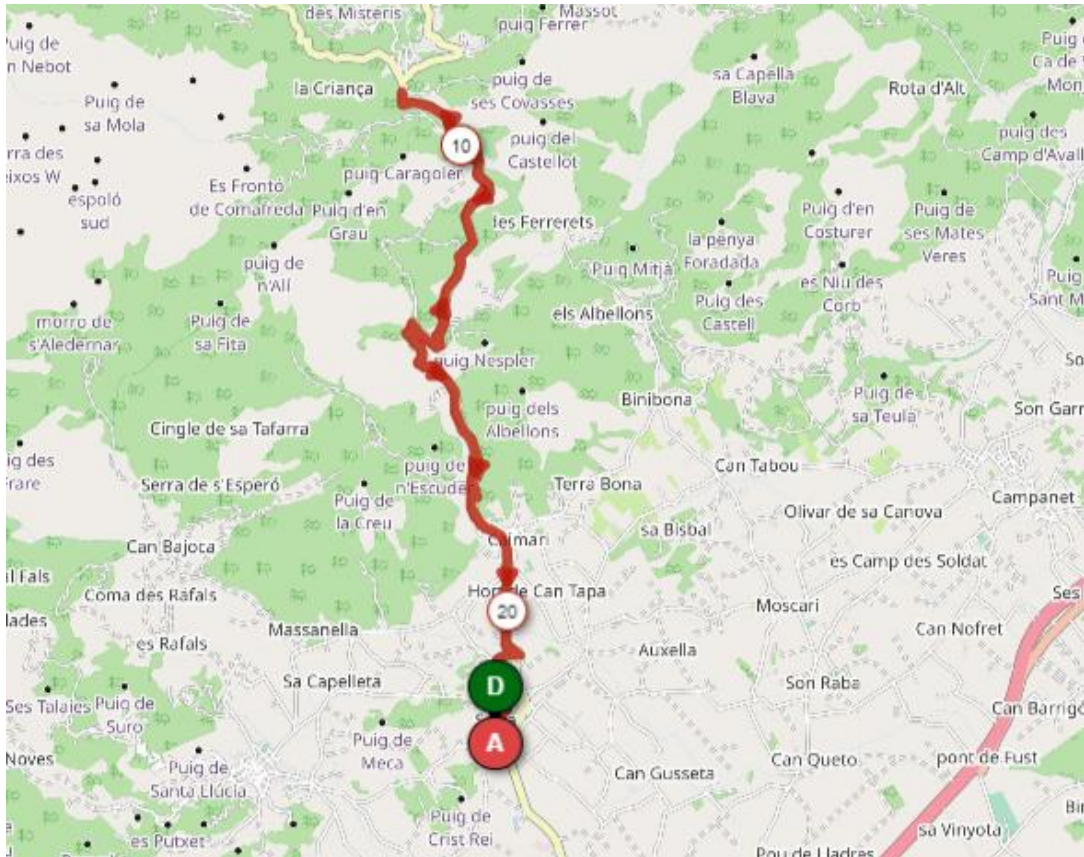

## Art. 2.- Price of registrations for both distances:

### Online registration through the official website of the event until October 16<sup>th</sup>, 2025 at 23.59h.

- 38 € Registration + 2 € for the chip of 1 use with federative license (Youth player, Junior, U23, Elite, Master or Cyclotourist). DOES NOT INCLUDE "CARNET CICLISTA". Ad 0.90€ administration fee will be added to online registrations.
- Supplement of 15 € for 1 day license without any type of cycling license (Registration until October 16<sup>th</sup> at 2 pm).

### Face-to-face registration at Selva – Plaça Major, on October 17<sup>th</sup>, 2025 from 6 p.m. to 8 p.m. (only registrations with Youth player, Junior, U-23, Elite or Master, female and male license)

- 45 € Registration + 2 € of the 1-use chip

**Face-to-face registration on the day of the race on October 18<sup>th</sup>, 2025 from 7.00 a.m. to 8.00 a.m. (only registrations with a Youth player, Junior, U-23, Elite or Master, female and male license and if there are entries available)**

- 60 € Registration + 2 € of the 1-use chip

**Art. 3.-** The registrations are considered final so, in the case of not being able to participate, only 100% of the amount paid will be refunded upon presentation of justification that will be valued by the organization until October 5<sup>th</sup>. As of October 6<sup>th</sup>, cancellations will not be accepted and the registration fee will not be refunded under any circumstances.

Registrations are strictly personal and non-transferable; they cannot be used by anyone other than the one registered. It is not possible to replace one participant with another.

The organizers will not assume any responsibility if the event is suspended or postponed for reasons beyond their control: health pandemics, terrorist actions, climatic circumstances, accidents or cuts in sections of the route, denial of government authorization for any reason or pretext, etc.

**Art. 4.-** The formalization of the registration, delivery of numbers and chips will be carried out:

**Selva – Plaça Major** on October 17<sup>th</sup> from 6 p.m. to 8 p.m.

**At the starting line (Selva)** on Saturday, October 18<sup>th</sup> (same day of the race) from 7.00 a.m. to 8.00 a.m.

To collect the bib number, **it is MANDATORY to present the ID, passport or some identity document and the license or cycling card, in case of having claimed to be federated.**

All participants must, compulsorily and visibly, carry the bicycle plate with the chip. A cyclist who does not visibly wear the bib number may be excluded from the route by members of the organization or by the law enforcement.

The plate and chip are personal and non-transferable items. The registered person can only participate with the number that has been assigned to him and agrees not to allow the use of it to other people.

**Art. 5.- Signature Control.**

A signature control is established on the day of the race from 7.45 a.m. to 8.15 a.m. All participants are required to sign at the specified time in order to compete.

**Art. 6.- Services to the participant.**

- Water at the top of Coll de Sa Batalla.
- Water and fruit at the end of the race.
- Commemorative jersey of the race.
- Gift: Mega Raw Bar protein supplement.
- Lunch after finishing: 1 portion of "fideuá/paella", 1 drink and "ensaimada" sample. Ticket for an accompanying person 10€ that can be bought during the registration.

**Art. 7.-** All participants will be covered by the accident policy of the federative license or with the coverage of the 1-day license contracted with the Organization.

Participation in the race is at the responsibility and own risk of the participants. The participant at the time of registration declares to be physically fit for the race.

**Art. 8.- The time control will be carried out electronically** through the use of a chip. In the registration, each participant must pay **€ 2**, for the acquisition of the chip. **It is mandatory to use the chip in order to obtain the time of the timed section. Participants must pass in Coll de Sa Batalla where the Organization has marked it and by the Finish line.**

**Art. 9.-** Any participant who is seen towed by any vehicle will be sanctioned by the Organization. **It is forbidden to have accompanying vehicles.**

**Art. 10.- Male and female categories by age**

- Youth player (only for the 42,8 Km distance)
- Junior
- U-23
- Elite
- Máster 30
- Máster 40
- Máster 50
- Máster 60
- For the 85,6 Km distance, a team classification will be established for clubs with a minimum of 5 registered participants. The winning team will be determined by the sum of the times of the 3 best classified teams. In the event of a tie, the team with the best places in the race ranking will be chosen.

**Art. 11.- Awards**

- Trophy and cash prizes **for the 85,6 km distance** (200€, 150€ and 100€) for the first three absolute male and female finishers.
- Trophy and cash prizes **for the 42.8 km distance** (100€, 75€ and 50€) for the first three absolute male and female finishers.
- Trophy for the first classified in each age category, male and female.
- Cash prizes (200€, 150€, 100€) for the first three teams classified in the 85,6 km distance.

The trophy ceremony will be held from 1:30 p.m. at the Plaça Major of Selva.

**Art. 12.-** The refreshment station in the middle of the circuit will be located in the Coll de Sa Batalla. There will be a refreshment of water and fruit next to the Finish Line.

**Article 13.-** The Organization will have, during the development of the race and permanently, a doctor and ambulance.

**Art. 14.-** The organization will have mechanical assistance throughout the race. In case of breakdown, labor will be free of charge, but spare parts will be borne by the participants.

**Article 15.- The use of a helmet and an appropriate bicycle is mandatory. Electric, TTI and mountain bikes are excluded.**

**Art. 16.-** The Organization is not responsible for any accident of which the participant could be a cause or victim, which are excluded from the insurance of the organization, nor is it jointly and severally liable for the expenses or debts that the participants may incur during the march, nor for the losses or breakdowns that the bicycles or other equipment of the participants may suffer. The participant exempts the organization from liability for loss or deterioration of personal belongings for any circumstance.

**Art. 17.-** The Organization reserves the right to make the appropriate modifications, when for any reason it deems it necessary. And likewise **reserves the Right of Admission**.

**Art. 18.-** Right to the image.- The acceptance of these regulations implies obligatorily that the participant authorizes the organizers of SALT DE TRAMUNTANA to the total or partial recording of his participation in it, gives his agreement so that he can use his image for the promotion and dissemination of the image of the SALT DE TRAMUNTANA in all its forms (radio, press, video, photo, DVD, Internet, posters, media, etc.) and assigns all the rights related to its commercial and advertising exploitation that it deems appropriate to execute, without the right on its part to receive any economic compensation.

**Art. 19.-** The mere fact of registering for this race implies acceptance of these regulations and the waiver of all rights against the organization. Waiving any legal action that may arise from their participation in the race.

**Article 20.-** Strictly, the penalty will be made for those participants who:

- Do not wear a helmet
- Do not respect the security instructions indicated by law enforcement or by the organization.
- Dirty or degrade the itinerary, throwing waste.
- Have their own support vehicle, hindering the progress of the rest.
- Behaviors that prevent the normal development of the race and that go against this regulation.

**Art. 21.-** By signing this contract (registration) you authorize UNISPORT CONSULTING SL to take photographs and/or make audiovisual media for commercial purposes. The images and/or videos will appear in the profiles managed by the company on various social media networks or be used for marketing campaigns related to events organized by UNISPORT CONSULTING SL or its associated companies (GERMATUR GESTION SL).
